2018 Market Street Facade Grant Program Application

Selinsgrove Projects Inc. encourages applications from businesses located within the Borough of Selinsgrove for the 2018 Market Street Facade Grant Program. The program provides financial support to encourage restoration projects to building facades and to enhance the appearance of downtown Selinsgrove. The grant program provides reimbursement of up to 50% of the total project cost to a maximum of \$5,000.

Eligible businesses must be located on Market Street, or within one-block of Market Street. Properties located within one-block of Market Street on High St., Water St., Chestnut St., Pine St., or University Ave. will also be considered. Market Street properties will be given preference. The 2018 Facade Grant Program is approved by the SPI board and made possible by the ticket sales from the annual Hops, Vines, and Wines Festival and other SPI fundraising activities.
